REGULAR TOWN BOARD MEETING

Meeting called to order by Chairman Nett. Present were board members: Jeff Nett, Robert Van, George Peterman, Patty Nett and Karin Hetcher. Public present was Tom Barker.

Motion by Supervisor Peterson to approve the agenda. Seconded by Supervisor Van. Motion carried. (board had quorum).

Motion by Supervisor Van to approve the minutes of the March 9, 2026 Board meeting. Seconded by Supervisor Peterman. Motion carried.

Treasurer's report by K. Hetcher: There were two checks that came to her attention that were not issued recently. Checks will be issued today.

Clerk's report by P. Nett: Received notice that postage may be raised. Election of April 6<sup>th</sup> went well. Had 431 voters. Received the billing from the WTA regarding their dues and the dues for the TAC which we paid yearly. Asked the Board if they wanted to continue to pay both in full. Motion by Chairman Nett to continue pay them both in full as previously done. Seconded by Supervisor Peterman. Motion carried.

Public comments by Tom Barker regarding his interest in running for town board supervisor.

Discussion on policy for tax overpayment refunds. No not need an ordinance just a policy. Chairman Nett read policy that was to cover the refund of tax overpayments of small amounts. Motion by Supervisor Peterman to approve the policy to cover amounts that are smaller than \$5.00. Seconded by Supervisor Van. Motion carried.

Discussion on wages for election workers. The fee has been \$100 per shift for many years. The job that they do is invaluable to running an election in out township. Motion by Supervisor Peterman to increase the amount per shift to \$125.00 starting with the August election. Fees for training at the beginning of a term to stay the same as they are presently. Seconded by Supervisor Van. Motion carried.

Fire district reports: Supervisor Van reports on Wautoma Fire District meeting.

Supervisor Peterman reports on Wild Rose Fire District meeting.
