

TOWN OF WITTENBERG

Monthly Town Board Meeting Minutes

June 17, 2025

The Town meeting was called to order by Chairman, Dick Beversdorf at 6:00pm. Present besides the Chairman were Supervisor Justin Hartleben, Supervisor Bill Timm, Clerk Maria Donat, Treasurer Jasmine Wolff, Maintenance & Road Supervisor Tom Knaup, Road Supervisor Rick Hartleben, Lori Studinski, John Powers, Carla Strassburg, Ron Lewis, Joe Ladika and Eric Letter.

Minutes from the May 20, 2025 Monthly Town Board Meeting were read. A Motion was made by Timm and seconded by J. Hartleben to accept them as read. Motion carried.

The Treasurer's Report was given and will stand as presented. Balances in the accounts are as follows: NOW Account = \$10,658.33; MMDA Account = \$320,575.64; Gardner Park Account = \$110,028.44; and Tax Account = \$10,042.37.

A Motion was made by J. Hartleben, and seconded by Timm, to deviate from the Agenda order. Motion carried.

Carla Strassburg and John Powers, from the Wittenberg Area Historical Society, expressed the financial needs for the design and construction of the new Wittenberg Historical Society museum and asked the town board if they would consider raising their annual membership amount to help with the yearly up-keep & expenses.

Joe Ladika, head coach for the Witt-Birn Girls Youth Softball and the American Legion Girls Softball programs, informed the town board on the current number of kids who have joined both programs this year, and the costs involved with traveling, hiring of umpires & needed equipment. Ladika thanked the board for their previous donations and stated that a donation this year would be a great help to both programs.

A Motion was made by J. Hartleben and seconded by Timm to approve the monthly bills & payroll checks numbered 12421 through 12448. Motion carried.

A Motion was made by J. Hartleben and seconded by Timm to approve a Class "B" Fermented Malt Beverage License and a "Class B" Intoxicating Liquor License to Maple Hills Golf Course, Rachel's Roadside Bar & Grill, Ho-Chunk Wittenberg Gaming Casino and Mahen & Maya LLC-d.b.a. Best Western Hotel. Motion carried.

A Motion was made by Timm and seconded by J. Hartleben to approve a Class "A" Fermented Malt Beverage License to Whitetail Crossing Convenience Store. Motion carried.

A Motion was made by J. Hartleben and seconded by Timm to approve a Class "A" Fermented Malt Beverage License and a "Class A" Intoxicating Liquor License to GPM Southeast-d.b.a. R-Store. Motion carried.

A Motion was made by Timm and seconded by J. Hartleben to approve a Cigarette, Tobacco & Electronic Vaping Device License to Ho-Chunk Wittenberg Gaming Casino, Whitetail Crossing Convenience Store and GPM Southeast-d.b.a R-Store. Motion carried.

A Motion was made by Timm and seconded by J. Hartleben to approve an Operator's License for Brandyn Dehart, Skyler Bourdon, Vanya Mower, Ella Eichman, Halle Beversdorf, McKenna Foster and Taneal Strassburger. Motion carried.

A Motion was made by J. Hartleben and seconded by Timm to approve a 6-month Class "B" Fermented Malt Beverage License to American Legion Men's Baseball. Motion carried.

The 2025 Blacktopping Road Bids were opened and discussed. A Motion was made by Timm and seconded by J. Hartleben to accept the following road bids from American Asphalt of Wisconsin.

Elm Rd.- Pulverize, Fine Grade, Pave & Shoulder for \$41,252.74.

Nightingale Rd.- Pulverize, Fine Grade, Pave & Shoulder for \$39,881.66.

Hummingbird Rd.- Pulverize, Fine Grade, Pave (no shoulder) for \$19,935.84.

Nightingale Rd. Patch- Pulverize, Fine Grade, Pave & Shoulder-west side of road for \$3,079.60. Motion carried.

Animal Control had no current activities to report. The Clerk informed the Town Board that the Village of Eland signed a contract with the Town of Wittenberg's Animal Control services to begin July 1st, 2025.

A Motion was made by J. Hartleben and seconded by Timm to approve a \$3,000.00 donation to the Wittenberg Area Historical Society. Motion carried.

A Motion was made by Timm and seconded by J. Hartleben to approve a \$3,000.00 donation to the Witt-Birn Girls Youth Softball program, and a \$3,000.00 donation to the American Legion Girls Softball program. Motion carried.

Road Supervisors Hartleben and Knaup had no current road or maintenance reports.

A Motion was made by Timm and seconded by J. Hartleben to adjourn the Town meeting at 7:46pm. Motion carried.
