Monthly Town Board Meeting Minutes
June 16, 2026

The Town Board meeting was called to order by Chairman- Dick Beversdorf, at 6:00pm. Present besides the Chairman were Supervisor- Bill Timm, Clerk- Maria Donat, Treasurer- Jasmine Wolff, and Road Supervisors- Rick Hartleben and Tom Knaup. Absent: Supervisor- Justin Hartleben
