Twin Lakes Township Wednesday, October 1, 2025 Town Board Meeting at the Twin Lakes Town Hall 5:00 p.m.

Derek Wolf, City of Carlton: Nelson Sanitation has completed the cleaning of the sewer lines in Olsonville and the lift station. Pump inspections have also been completed. The Casino hooked up to the township water system to perform maintenance on their system, it went well. Smoke testing the sewer system will happen on October 7 and Derek should be contacted if there are complaints of smoke issues that day.

Suggested roads are West Chub Lake Road, Lakeview Drive, Lac La Belle Road and the remainder of Hay Lake Road.
- Lac La Belle Road: No time frame yet on when black topping will be done. Olean checks in on it weekly.
- Douglas Road: The guardrails are complete as of today.
- West Chub Lake Road: The board has requested that our engineer look at the road and what speed it was designed for.
- Utility Rate Study: A follow-up meeting with Ehlers happened today and there will be a presentation at the next board meeting.
