- Utility Rates: The board reviewed a new resolution of water and sewer rates, as drafted by our attorney. MOTION to approve the Resolution Establishing Water and Sewer Rates and Charges was made by Willie and seconded by Orlowski; all voted yes, the motion passed.
- Delinquent Utility Payments: MOTION to authorize Carlton County to collect delinquent utility charges plus late fees in the following amounts from the property taxes of Mary Ableiter Estate \$732.82, Harold Horner \$732.82, Michael Pydynkowski \$732.82, Jillian & Jeffery Wartner \$412.72 and Christopher and Tara Hietala \$500.19, was made by Willie and seconded by Orlowski; all voted yes, the motion passed.

# **NEW BUSINESS**

- Lumen: A permit request was received to bury communication lines near 2216 Hay Lake Road. Discussion was held with a caveat that the line is buried at least 3 feet. MOTION to approve the permit for 2216 Hay Lake Road was made by Felde-Finke and seconded by Willie; all voted yes, the motion passed.

#### ROAD MAINTENANCE

- Evergreen Drive: An email was received from a resident that her driveway was filled in a bit and now looks more sloped.
- Leimer Road: Resident contacted township about a couch that was dumped at the end of the road. Korienek will remove it.
- Cologne Road: Orlowski asked about truck traffic on the road since it has been paved. No one has heard anything.
