

**MINUTES**

**Town Board Meeting at the Twin Lakes Town Hall**  
**5:00 p.m.**

Board Chair Diane Felde-Finke opened the meeting at 5:00 p.m. Other board members present: Supervisor Randy Willie, Supervisor Mike Orlowski, Treasurer Cortney Carlson, Clerk Sue Chapin, Deputy Clerk Daisy Rose.

**Guests:**

Trent Prigge, NCE: He reported that the county is still working on future paving project road plans. Plans for Lac La Belle Road, Hay Lake Road and possibly Lakeview Drive will be completed soon. Plans for West Chub Lake Road won't be completed until end of December/beginning of January. Prigge will check with the county for previous road plans for the first 1 ½ miles of West Chub Lake Road to verify the buildup that was last done underneath the pavement.

The board reviewed Wolf's lift station report.

**MOTION to approve the November 19, 2025 town board meeting minutes as printed was made by Willie and seconded by Orlowski; all voted yes, the motion passed.**

**MOTION to pay all bills, check numbers 19452-19458 and electronic payment 941DEC25 for the total amount of \$59,059.18 was made by Willie and seconded by Orlowski; all voted yes, the motion passed.**

Carlson presented the treasurer's report.

**OLD BUSINESS**

- Yndestad Road: Money in the RBC account reflects payment from Enbridge for Yndestad Road paving project. Discussion was held on having Carlson contact RBC to see if we could get a larger return on our investment. The board agreed that she should do this.

- Minnesota Power: A permit request was received to bury lines under the road at 1797 Douglas Road. **MOTION to approve the permit for 1797 Douglas Road was made by Willie and seconded by Orlowski; all voted yes, the motion passed.**

- Clerk Position: Appointment of new clerk. **MOTION to approve appointment of Daisy Rose as Twin Lakes Township Clerk, effective January 1, 2026 was made by Felde-Finke and seconded by Orlowski; all voted yes, the motion passed.**

- Town Hall Rental: An application was received from Lisa Berube for town hall rental on June 12 from 1 p.m. to 8 p.m. for a graduation party. **MOTION to approve Lisa Berube's application for town hall rental on June 12, 2026 was made by Willie and seconded by Orlowski; all voted yes, the motion passed.**
