

**MINUTES**  
**Twin Lakes Township**  
**Wednesday, January 7, 2026**  
**Town Board Meeting at the Twin Lakes Town Hall**  
**5:00 p.m.**

Board Chair Diane Felde-Finke opened the meeting at 5:00 p.m. Other board members present: Supervisor Randy Willie, Treasurer Cortney Carlson, Clerk Daisy Rose. Also present: Road Foreman Bob Olean and Dominick Phaller. Absent: Supervisor Mike Orlowski.

**Guests:**

Derek Wolf, City of Carlton: Locates completed for gas main replacement by booster station. Black Bear is installing a grinder pump in the casino lift station. The property at 1597 Highway 210 is in the process of being sold. Wolf received sewer lateral line inspections for both sewer lines on the property. There are also two water hook-ups located at the property, the board was in agreement that both should be included on the utility bill at the water availability rate.

Trent Prigge, NCE: Prigge is working on the I&I meeting report and will plan to have it at the February 4<sup>th</sup> meeting for board approval. Prigge reviewed the road plans received from the county, and he offered his approval from the engineering standpoint.

**MOTION to approve the December 17, 2025 town board meeting minutes as printed was made by Willie and seconded by Felde-Finke; Willie and Felde-Finke voted yes, Orlowski was absent, the motion passed.**

**MOTION to pay all bills, check numbers 19473-19485 and electronic payment 941JAN26 for the total amount of \$61,531.36 was made by Willie and seconded by Felde-Finke; Willie and Felde-Finke voted yes, Orlowski was absent, the motion passed.**

Carlson presented the treasurer's report.

Carlson provided an update on RBC money that was placed into CD's. The amount of money, \$540,089.02, for FDIC insurance reasons was split into 3 CD's, two with \$250,000.00 each at 3.55% interest and the remaining balance on a third CD at 3.5% interest.

**OLD BUSINESS**

- 2026 Road Plans: Board reviewed the 2026 road paving plans designed by the county: West Chub Lake Rd (TLT 2026-01) and Lakeview Drive (TLT 2026-03), FDR, 4" bituminous overlay, aggregate surfacing special on shoulders and replace mailbox supports. Hay Lake Road (TLT2026-02) and Lac La Belle Road (TLT2026-04)-2.5" bituminous overlay. **MOTION to approve the above Twin Lakes Township road paving plans to be included in the Carlton County 2026 bid proposal was made by Willie and seconded by Felde-Finke; Willie and Felde-Finke voted yes, Orlowski was absent, the motion passed.**

- Roadside Mowing: A letter was received from Jerry's Roadside Mowing stating he will no longer be conducting business. The board will need to look for a new roadside mower.
