The meeting was held both in person and via remote access. The requirements of the open meeting law were certified as being met. The Pledge of Allegiance was recited.

MINUTES OF 11/09/2022

Motion/second (Boutwell/Schweder) to approve the minutes of the 11/09/2022 meeting. Motion carried with no negative vote.

PUBLIC COMMENT – none

APPEARANCES

- Art Cybul, Village of Marquette, CTH H

Art Cybul, President of the Village of Marquette, appeared to inform the committee of the need to reconstruct CTH H. He provided a presentation and also submitted a petition with 150 signatures from area residents. Cybul stated that this project was originally on the road improvement plan in 2021 but it has never been done. Due to a Lake Puckaway project in 2023, Cybul stated that he would like to make sure the CTH H project gets done in 2024 or 2025. Discussion held with input from Highway Commissioner Derek Mashuda. This will be placed on the agenda for next month for further discussion.

2023 WINTER ROAD SCHOOL, JANUARY 23-25, 2023

Committee members all received information regarding the winter road school in January. ***Motion/second (Schweder/Buss)*** to approve the request to attend for Chuck Buss. Motion carried with no negative vote.

ORDINANCE

- **Amending Ordinance 855-06 to Adopt the Wisconsin County Highway Association Utility Accommodation Policy**

Highway Commissioner Derek Mashuda stated that the WCHA has drafted a policy to hold utility companies/contractors to certain standards when work is done within the county. Mashuda recommends adopting the policy. ***Motion/second (Buss/Schweder)*** to approve the ordinance and forward to County Board for final approval. Motion carried with no negative vote.

FINANCIALS

Highway Commissioner Derek Mashuda gave an overview of the financials. No questions or discussion on this item.

RAILROAD CONSORTIUM

Chair Mulder stated that the railroad consortium has raised the annual membership contribution from \$25,000 annually to \$30,000 for 2023. ***Motion/second (Buss/Wielgosh)*** to approve the increase for the railroad consortium. Motion carried with no negative vote.

COMMISSIONER'S REPORT

Highway Commissioner Derek Mashuda provided an update to his submitted report. Comparables provided on the new track skidloader purchase for the highway department. Mashuda stated they will be purchasing the Caterpillar for \$89,000.

Green County does not have a year round 4-10 schedule. The county is however looking at this for all departments. We currently do 4-10's during the construction season that varies but can run April through October. This year we have so much work that we are going to the week before Thanksgiving. I have been keeping track of the dates of the snowfalls in the winter and so far we would be ahead as it seems we would pay less overtime on the days when we are here and it seldom snows on Fridays (for the past year in Green County). At best it seems it would be a push. Snow typically falls during the evening and early morning hours. I would be interested in any data you find on this subject.

Eau Claire County: We're on 4-10's year around for field staff, but Admin staff is on 5-8's due to county code requiring offices to be open to the public Monday-Friday. I had some cost comparison information from back in 2017-2018 when we started our pilot but no longer keep any current data.

The number one pro to having 4-10 year around is employee retainage. When we survey our staff, they say the best benefit we have is the 4-10 year around. There's some savings here and there depending on the amount of winter events we receive on a Friday, as well as not having to use as much utilities on a Friday by not being out.

Dunn County: We have been doing 4 - 10's all year for the past 6 years. We have not necessarily monitored the cost difference, but our winter maintenance has stayed status quo from the 4 - 10's to 5 - 8's. The biggest reason for the change was for moral issues, and to get more accomplished in a 10 hour day vs. an 8 hour day. It does pose an issue with response time in particular on Friday's for winter plowing, but our staff has been reliable. We did let them know if it becomes a problem on Friday's that we would be going back to the 5 - 8's.

Buffalo County: We have been year round 4-10 hour days for about 5-6 years now. Attached please find an Excel worksheet showing estimated cost savings for mobilization during the winter months of Nov 1st-Mar 31st. I believe last year when I attended the CHEMS conference I was asked about our documentation of savings for year round 4-10s, but I didn't follow up because the cost savings done in 2015 or 2016 were challenged due to using only one crew to do winter brush cutting and the cost savings were believed (by the county highway committee) to be potentially inflated as we pulled labor and equipment from all outlying shops to one singular location. In 2021, another cost savings estimate for mobilization was done using two crews (split) and two locations to show a more accurate estimate of mobilization savings for the twenty-two weeks of the winter. These estimates were based upon real data. Please keep in mind that there are other uncalculated cost savings from a four day week to include heat and other overhead expenses; however, the best reasons we have found to do a year round modified 4-10 work week is employee morale and the carrot to bring on new hires – especially since our starting patrol wages are definitely not the highest.

Polk County: We do 10 all year- I put in the winter of both 2014 and 2015 in a 8 hour and 10 hour scenario. The difference was plus and minus one hour for each year, so a wash.

Pepin County: We work 4 – 10 hour days year round, been that way since I started. I have only been here 2 years but my assumption is that it is cost effective to not be open one day and it is working.

Rusk County works 4, 10-hour days per week year round. We have not done a study for many years, but I attached a wage study and our heat bill study done by my predecessors. They may be too old to be helpful. ???

Lincoln County has been 4-10 year round since 2017. I fear the paperwork to prove the savings has been lost a couple of commissioners ago but I will continue to look and update everyone if something is found.

Florence County does 4-10's all year round. This will be our second winter with the 4-10's. When looking into if we should try it or not, we pulled reports in CHEMS of the Friday's worked during the winter to see how often they were plowing during "working hours". Interestingly enough, it wasn't as often as we thought.

Oneida typically does not do 4-10's year round but this year we are trying it through the 1st of the year. We will see how it goes then.

We at Kenosha County work 4-10s year round. We don't have any analytical data readily available so I will see what I can put together comparing years of only summer days on 4-10's and winter on 5-8's. I believe at one point I had put something together to see "how often it snowed on Fridays" but I can't remember exactly what came of it. We do, for the time being, continue to have a staff (I believe around 10 people) of second shift who work 5-8s throughout the winter however they are discussing transitioning them to 4-10s in the future as well, I would assume likely a Tu-Fr as the rest of the staff mainly works M-Th. I believe the main reasoning in transitioning, was the benefit of longer hours to complete jobs or be available for snow removal, similar to paving in the summer, as well as a benefit to the employees as many view the 4-10 shift as perk of receiving a 3 day weekend. We also recently adjusted holiday's to be 10 hours for these guys as well, as previously it was 8 hours and they would have to use 2 hours of PTO or unpaid time as an offset.

Chippewa County works 4 10 hour days for almost the entire year. We work Jan. to March 6:30am – 4:30pm, April to up to Thanksgiving week 6:00am – 4:00pm. Thanksgiving week until the end of December changes to 5 8 hour days of 7:00am to 3:30pm. This will be our second year of this scheduling.

Grant County is looking for ways to retain employees, and adjusting the 10 hour days was an option. Currently we begin 10 hour days the first full week of May, and end the third full week in October. I would really be interested in the results of this survey.

Forest County: We just started doing 4 – 10s year rounds. This will be our first full winter doing this and as of now we are planning to stay 6am – 4pm year round.

Langlade County: We work 4-10's year around. The whole Highway department does.(Office workers and Highway workers)
We started doing this when COVID hit and we have continued it since.

Washburn County works 4 – 10 hour days year round with just the starting & ending time being adjusted from 6:00 to 6:30 a.m. and 4:00 to 4:30 p.m. in the winter months.
I'll see if I can find our past analysis material for you

Taylor County does 4 – 10's year-round. Attached are two documents we use to calculate our savings.

Trempealeau County used to do 10's in the summer and 8's in the winter. When our current commissioner started out here about 4 years ago, he liked the 4 10 schedule all year long and the Highway Committee was ok with it.

And so it came to be ☺

That's all I can give you, other than we get some holidays at 10 hours and the winter holidays at 8 hours paid. So for those we have the option to come in and work 2 hours or use vacation. That way the Courthouse is happy.

Mobilization Savings: Save on mobilization costs and time for mobilizing 4 day instead of 5

More efficient use of time in office and in the field because of the mobilization savings and start up activities each day.

Cost savings: Heat, Gas, Diesel Fuel, Electricity, Overtime

Improves Employee Morale: Perk to keep employees happy, to retain employees, to help in recruiting new employees

14 Counties out of 71 currently working 4-10's year round. 13 of the 14 are northern counties.

19 of the 38 Counties not on 4-10's year round are interested in the results of the survey.

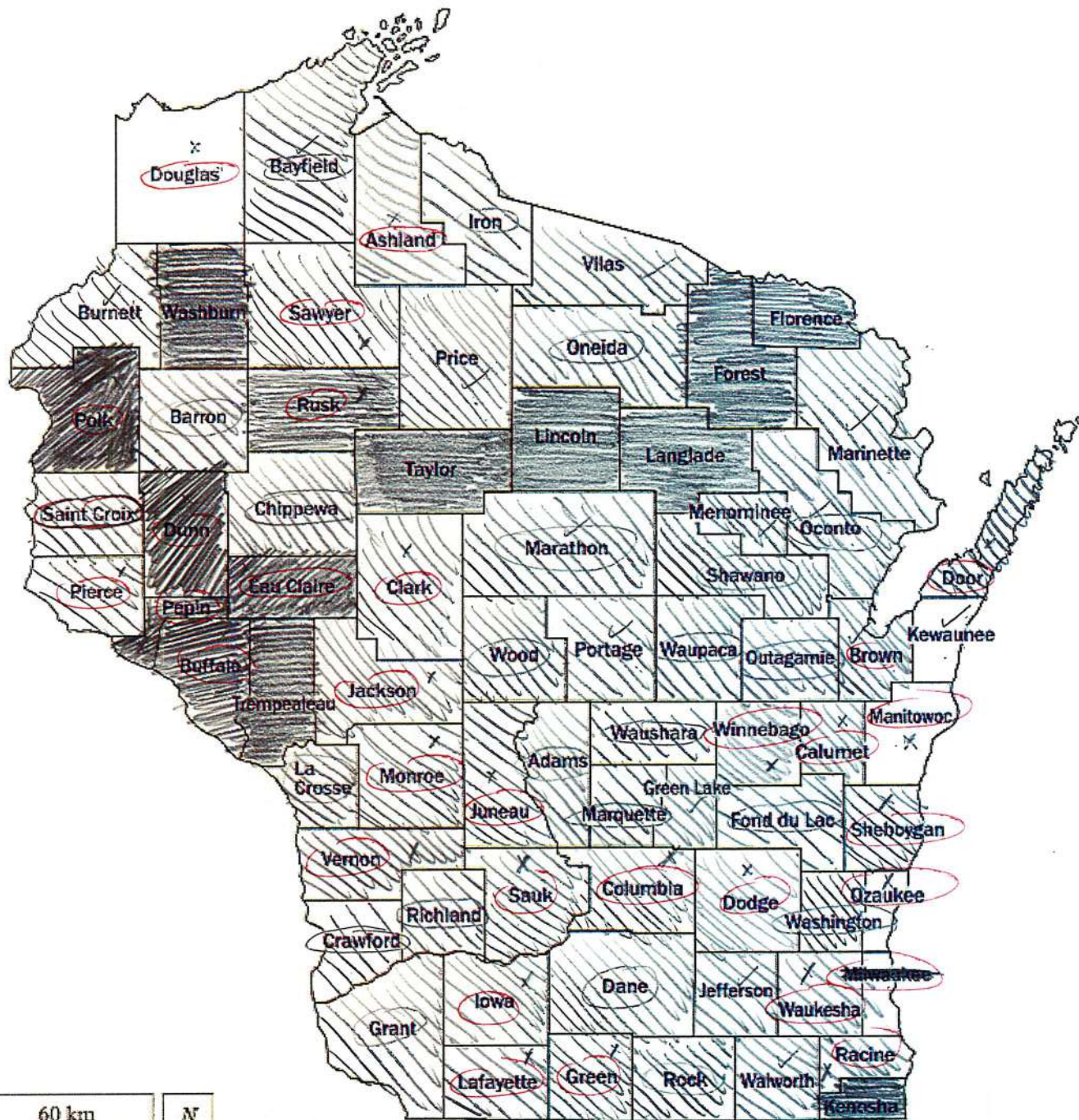

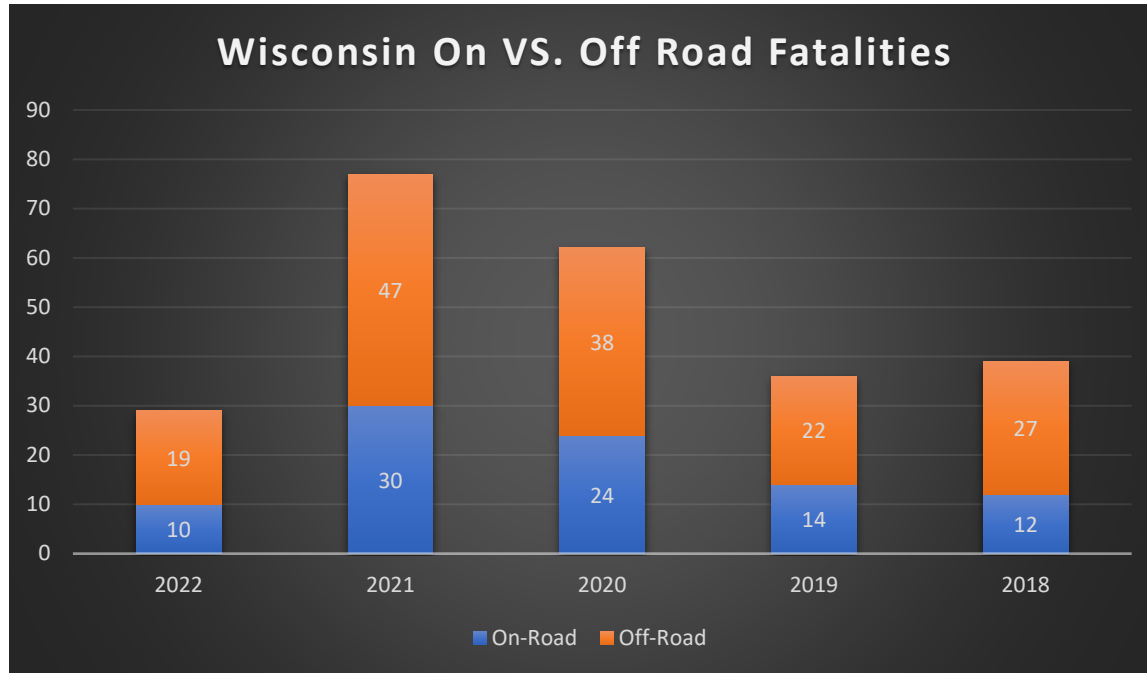

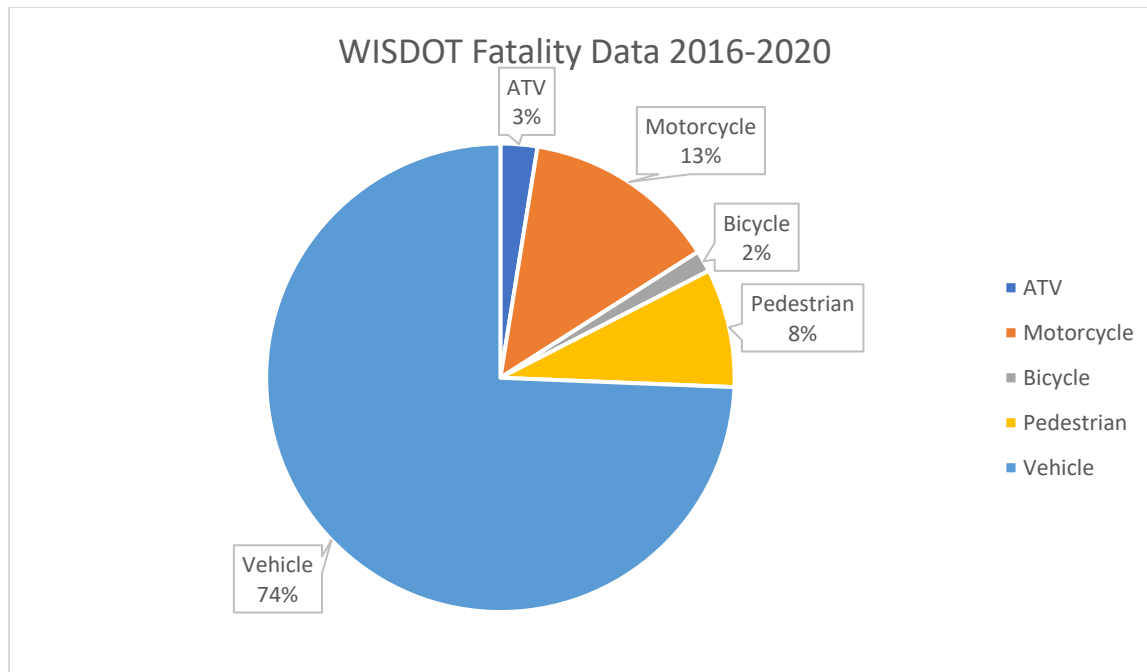

Out of these on-road incidents in 2022, 5/10 with 3 pending were intoxicated. In 2021 16/30, 2020 12/24, 2019 14/14, and 2018 6 /12 with 4 pending on road incidents had intoxicated operators. Out of the 90 incidents in the last 5 years of fatalities recorded in Wisconsin, only 2 of these incidents had an operator wearing a helmet. The other 88 fatalities were shown to not have the proper protective gear while riding on the roadway. WISDOT's most recent data shows the breakdown of all modes of transportation fatalities within the state. The data are the most current and official numbers as there is some lag while investigations remain open in some cases. ATV data was added from the same date range as comparison with the DOT records for on road fatalities. ([Wisconsin DMV Official Government Site - Final year-end crash statistics \(wisconsindot.gov\)](https://wisconsin.dmv.gov/crash-statistics))

Out of the 404.98 miles in the municipalities of Green Lake County, 310.45 miles are now open to ATV's in the county. That's over $\frac{3}{4}$ already. With the likely opening of the Town of Berlin and Town of Seneca, that would make the total 362.98 miles open out of 404.98. Leaving the town of Marquette, Village of Marquette, and the City of Green Lake the only municipalities that remain closed to ATV traffic.

Opening up all county roads with the current municipalities that are open would allow for 487.1 miles open out of the 633.92 miles of roadway in the county. Opening the Town Seneca and Town of Berlin would put the county at 576.83 miles out of 633.92 miles in the county open to ATV.

Speaking with colleagues throughout the state, none have reported any issues with opening larger portions of their roadway systems. Most have said it has been seamless and a non-issue. Some counties have chosen to open 100% of their roads, others have opened all with some exceptions. Exceptions tend to be roads with heavy truck traffic, sections close to interstate highways, or some go off of ADT with the range being roads open from 1000 ADT or less all the way up to 2500 ADT or less.

The cost to the county for signage would be approximately \$8,774 to post proper trail signage. According to SS 23.33(9) there is funding available for the placement of signage to develop ATV routes. This comes out of the DNR vehicle registration fund. In addition, enforcement funding is available to help local enforcement agencies with the additional cost to enforce the use of ATV traffic on the roadway systems. There is also money available for training on how to enforce the ATV's on the road. This all comes from the DNR out of the vehicle registration fund and is available to local enforcement agencies.

There are plenty of reasons to update our ordinances to align with the current times in our world. Data shows no significant safety concern if all rules and guidelines are followed to allow ATV/UTV's on the roads. Riding an ATV/UTV on the roadway is safer than walking or riding a motorcycle according to the data. UTV's provide much more protection than walking, biking, riding a moped, riding a horse etc. They have full roll cages to protect the occupants of the machines.

ATV/UTV's are also much lighter than a car or truck. The average car on the roadway weighs 4,094 LBS. The average truck weighs somewhere between 6,000-8,000 LBS. The average UTV only weighs 1,400 LBS. That is less wear and tear on the road base and sub-base system. The tires are also much softer and less abusive to the surface of our roads. If someone wants to run to the grocery store or out to grab lunch and would rather take an ATV/UTV, why not let them? It's better for our road's longevity.

There is also the potential for increased revenue into the county and to our local businesses. With all of the outdoor activities and fishing in the area, having the capability to run your ATV/UTV to the lake or woods would likely spread the income to the local businesses on the way as well. Grabbing supplies, food, fuel, and so on could potentially generate additional revenue in the county. Not to mention the scenery of Green Lake County bringing potential visitors to the area to ride and stay at local inns and motels.

By opening up all of our county roads to ATV's, in addition to the benefits of the general public, this will allow more time for the highway department staff to focus their goals on the important matters regarding the maintenance of our roadway systems. The amount of time wasted dealing with ATV permitting and mapping is simply not sensible and never recovered. This topic should undergo serious consideration and be put to rest.

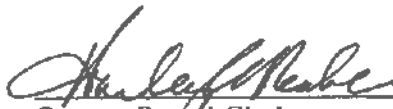
WHEREAS, one or more individuals, associations or organizations are interested in sponsoring designated ATV routes on County Trunk Highways and have indicated a desire to support the costs involved in installing signs for the designated ATV routes by underwriting the costs involved; and,

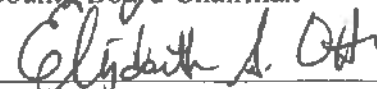
WHEREAS, the Green Lake County Highway Committee and the Highway Department have received requests for designation of portions of County Trunk Highways as ATV routes.

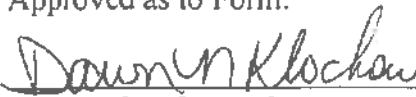

Section 2. Chapter 257, All-Terrain/Utility-Terrain Vehicles is created as follows:

§257-1. Authority.

This Chapter is adopted under the authority granted by §§59.02 and 23.33 (8)(b) and (11) Wis. Stats. and Wis. Admin. Code NR §64.12.

§257-2. Title.

This Chapter shall be known as, referred to, or cited as the "Green Lake County All-Terrain/Utility Terrain Vehicle, (ATV/UTV) Ordinance."

§257-3. Jurisdiction.

This Chapter shall regulate the operation of all all-terrain/utility-terrain vehicles in all areas of Green Lake County.

§257-4. Adoption of Statutory Provisions.

Except as otherwise specifically provided in this Ordinance, the statutory provisions in Chapters 23, 340 to 348 and 350 of the Wisconsin Statutes, establishing regulations with respect to all-terrain vehicles (ATVs), utility terrain vehicles (UTVs) and Wisconsin Administrative Code Chapter NR 64, All Terrain Vehicles are hereby adopted by reference and made a part of this chapter as if fully set forth herein. Unless otherwise provided in this ordinance, any act required to be performed or prohibited by any statute incorporated herein by reference is required or prohibited by this ordinance. Any future amendments, revisions or modifications of the statutes or administrative codes incorporated herein are made a part of this chapter to secure uniform statewide regulation of ATVs and UTVs.

§257-5. Definitions.

The definitions of words and phrases as they appear in §§23.33(1), 340.01, 341.01, 342.01, 343.01, 344.01, 345.01, 346.01, 347.01 and 348.01 Wis Stats. and Wis. Admin. Code NR §64.02, unless the word or phrase is defined differently in this chapter, are hereby adopted and made a part of this chapter as if fully set forth herein. Any future amendments, revisions or modifications of the statutes or administrative codes incorporated herein are made a part of this chapter to secure uniform statewide regulation of ATVs.

As used in this Chapter:

"Sponsor" means an individual, organization, ATV or UTV club, or municipality that submits an application to the Highway Department for the designation of a County Trunk Highway as an ATV route and will pay for the costs to make, install, and maintain ATV route signs.

79 **§257-6. Delegation to Highway Committee.**

81 The Green Lake County Highway Committee ("the Highway Committee") is authorized
82 to designate segments of Green Lake County Trunk Highways as ATV routes, in

- 144 an ATV route and efforts to establish off-road alternatives.

- 146 5. If the applicant is an organization, the names and addresses of its officers, the date
- 147 when the organization was established or incorporated and the number of
- 148 members.
- 149
- 150 6. A statement that the applicant will sponsor and be financially responsible for
- 151 payments for the installation and maintenance of the required ATV route signs
- 152 required by applicable state statutes and administrative codes and §257-9.
- 153
- 154 C. The Highway Commissioner shall review the application for conformance with
- 155 Highway Department policies, this ordinance and with all applicable state, federal
- 156 and local laws, regulations, and policies.
- 157
- 158 D. The Highway Commissioner shall make a report and recommendation to the
- 159 Highway Committee regarding any request for a designation of a segment of County
- 160 Trunk Highways as an ATV route. The report shall include information regarding
- 161 topography, traffic patterns and uses, and other information which may bear on the
- 162 safety and appropriateness of the proposed designation, including, any information

165 **§257-9. Maintenance of ATV Routes.**

- 167 A. A sponsor shall pay for the projected ten-year cost of procurement, installation, and

Designation of segments of the Green Lake County Highway System as ATV routes does not impose upon the Green Lake County Highway Department a greater duty of care or responsibility for maintenance of those segments than for any other segment of county highway. Operators of ATVs on county highways designated as an ATV route assume all the usual and normal risks of ATV operation.

§257-10. Signage of ATV Routes.

- A. The Green Lake County Highway Department is solely responsible for ATV route signing. All required designated ATV route signs shall be installed and maintained by the Highway Department.
- B. All required signs shall be in accordance with state statutes and administrative codes applicable to ATV routes on County Trunk Highways.
- C. No person may erect, remove, obscure, or deface any official designated ATV route sign unless authorized by the Highway Commissioner.

§257-11. Operation on All-terrain/Utility-terrain Vehicle Routes.

- A. No person shall operate an ATV or UTV on a county trunk highway unless the county trunk highway has been designated as an ATV route by the Highway Committee and approved by the County Board of Supervisors, except for operation that is allowed under state statute or administrative code.
- B. No person shall operate an ATV or UTV on a county trunk highway designated as an ATV route if the County Trunk Highway is closed for any reason.
- C. General limitations. The following limitations apply on all county trunk highways designated as ATV routes:
1. Operators shall abide by all traffic laws unless further restricted by this Ordinance.
 2. No ATV or UTV shall be operated at a speed greater than 25 miles per hour unless a reduced speed is otherwise required by State Statute.
 3. All ATVs and UTVs must operate with fully functional headlights, tail-lights, and brake lights.
 4. ATVs and UTVs may only be operated on an approved ATV route between one half hour before sunrise and one half hour after sunset from April 15th through November 15th.
 5. All ATV or UTV operators shall ride in single file on the extreme right hand side of the paved portion of the highway. Operation on the gravel shoulders, grassy

in-slope, ditches, or other highway right-of-way is prohibited unless yielding the right-of way. Left turns may be made from any part of the highway when it is safe given prevailing conditions.

6. Crossings should be made only at a place where no obstruction prevents a quick and safe crossing. "Obstruction" includes, but is not limited to impairment of view and potentially hazardous roadway conditions.
7. All ATV and UTV operators and passengers under 18 years old shall wear protective headgear while operating on county trunk highways.
8. No person under the age of 16 may operate an ATV or UTV on any segment of a County Trunk Highway that is a designated ATV route.
9. Every person who operates an ATV or UTV on any segment of a County Trunk Highway which is designated as an ATV route shall have in his or her immediate possession an valid motor vehicle operator's license, and shall display the license document upon demand from any law enforcement officer, state patrol officer, inspector under Wis. Stat. §110.07(1), conservation warden or municipal peace officer.
10. No ATV or UTV may be operated on any designated ATV route if the ATV or UTV does not meet all applicable Federal noise and air pollution standards.
11. No person may ride in or on any part of an ATV or UTV that is not designated or intended to be used by passengers.

§257-12. Enforcement.

- A. This Ordinance shall be enforced by any officer employed by the Green Lake County Sheriff's Office or any other law enforcement official as set forth in Wis. Stats. §23.33(12).
- B. Adoption of this ordinance shall not prohibit any law enforcement officer or DNR warden from proceeding under any other ordinance, regulation, statute, law or order that pertains to the subject matter under this Ordinance.

§257-13. Violations and Penalties.

Any person violating any provision of this chapter shall, upon conviction, forfeit a dollar amount not to exceed the maximum dollar amount of the forfeiture provided in the subsection(s) of Wisconsin Statutes violated, together with all applicable costs, and in default of payment of such forfeiture and costs shall be confined in the Green lake County Jail until such forfeiture and costs are paid, but not to exceed 30 days.

§257-14. Severability.

Should any portion of this Ordinance be declared by a court of competent jurisdiction to be invalid, the same shall not affect the validity of the Ordinance as a whole or any part thereof, other than the part declared invalid.

Section 3. This ordinance shall become effective upon passage and publication.

Section 4. The repeal of Ordinance Number 407-90, enacted on February 20, 1990 shall not have any effect on existing litigation and shall not operate as an abatement of any action or proceeding then pending under or by virtue of the repealed ordinance.

18 effort to assist the Wisconsin Counties Highway Association and the WCA request of
19 additional funding through budgetary surplus be allocated to the county GTA
