Citizen Comments - Time Limits

Rudy Winther from the Historical Society asked if he could host a Fraud Prevention Program from National Exchange Bank for the citizens of Marquette at the Village Hall. He will let us know the date and time in February.

Rudy also asked if there was a time line for the cement pad in front of the Historical Society to be poured. It will be done in the spring with the other cement pads. Follow up with the county to check timelines will be done.

Discuss/Approve:

Status of Taxes paid and dog licenses

Ditch on Center Street

The President will follow up with Derek Mashuda to see when work will start on cutting down the trees and clearing the land.

Lawn Cutting Contract

Trustee Deiss will follow up with Farmer Kathy on the status of a new lawn contract for 2026.

Adding Light to 2nd street

The Village board will reach out to Alliant Energy regarding a light installed on a pole on 2nd street and will see if any other locations could benefit from lighting.

New garbage and recycling pick up day
