### **Appoint Clerk for a 2-year term and increase salary**

The Clerk Susan Gheraldi was reappointed to a 2-year term and increase salary to \$10,000. yearly. The President recused himself. The motion was made by Michalos and seconded by Deiss. Motion passed. 2 yes 1abstain
