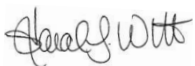

RESOLUTION No. LL0012025.2

Enacting Local Law No. 1 of 2025 Amending the Zoning Map Contained in Section 230-7 and Attachment 3 to Chapter 230 of the Village Code to Alter the Boundaries of the RU Zoning District to Include Eight (8) Parcels Currently Located in the RLD Zoning District

At a meeting of the Village Board of Trustees of the Village of Millbrook (“Village Board”), held at the Village Hall, 35 Merritt Ave., Millbrook, New York on the 12th day of February, 2025, at 6:00 p.m., Village Mayor, Peter Doro called the meeting to order, and Trustee Murphy, seconded by Mayor Doro, moved the following resolution, to enact the following local law, to be known as Local Law No. 1 of 2025, entitled “A Local Law Amending the Zoning Map Contained in Section 230-7 and Attachment 3 to Chapter 230 of the Village Code to Alter the Boundaries of the RU Zoning District to Include Eight (8) Parcels Currently Located in the RLD Zoning District” as follows:

WHEREAS, the following Local Law was introduced as Proposed Local Law No. 10 of 2024, by Resolution adopted at a regular meeting of the Village Board held on December 11th, 2024; and

WHEREAS, Proposed Local Law No. 10 of 2024, was duly referred to the Dutchess County Department of Planning and Development pursuant to Section 239-m of the New York General Municipal Law and the Dutchess County Department of Planning and Development responded to the referral by stating this is a matter of local concern; and

WHEREAS, a properly noticed public hearing was held before the Village Board during the meeting on February 12th, 2024, on Proposed Local Law No. 10 of 2024, to be enacted as Local Law No. 1 of 2025; and

WHEREAS, the proposed Local Law set forth below is incorporated herein as if recited verbatim, and the Village Board directs that said Local Law be recited in the minutes of this meeting as if it, in fact, had been read verbatim during the meeting; and

BE IT ENACTED by the Board of Trustees of the Village of Millbrook (“Village Board”) as follows:

Section 1. Declaration of intent. On August 14, 2024, the Village Board imposed a temporary moratorium on all parcels located in the Residential Low-Density (RLD) Zoning District in the Village in order to give the Village Board time to review and consider possible changes to the zoning regulations applicable to property in the RLD Zoning District with respect to minimum lot acreage and other density requirements. After conducting such a review, the Village Board has determined it to be in the best interests of the Village to remove the eight (8) parcels of property designated by Tax Parcel Nos. 6765-00-546544, 6765-14-420427, 6765-14-441448, 6765-14-429464, 6765-14-432485, 6765-00-463534, 6765-00-465569, and 6765-00-465580, from the RLD Zoning District and include them in the Rural (RU) Zoning District. The Village Board has determined such changes to be necessary in order to make those parcels subject to the greater Lot and Bulk requirements of the RU Zoning District without significantly changing the allowable uses for those parcels as the uses allowed as of right are essentially the same in the RLD and RU Zoning Districts. The Village Board determined the greater Lot and Bulk requirements are needed for these parcels given the existing infrastructure in the Village.

Section 2. The Zoning Map contained in Section 230-7 and Attachment 3 to Chapter 230 of the Village Code is hereby amended to remove the parcels designated by tax parcel identification numbers 6765-00-546544, 6765-14-420427, 6765-14-441448, 6765-14-429464, 6765-14-432485, 6765-00-463534, 6765-00-465569, and 6765-00-465580 from the RLD Zoning District and include those same parcels within the boundaries of the Rural (RU) Zoning District. The amended Zoning Map to accompany and be a part of Section 230-7 of the Village Code is annexed

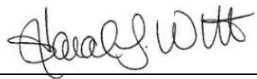

Section 3. This local law shall take effect immediately upon filing with the New York State Department of State.

THEREFORE, BE IT RESOLVED:

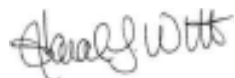
1. The Village Board shall act as lead agency for the environmental review of the Project as there are no other involved agencies.

NOTICE OF DETERMINATION OF NON-SIGNIFICANCE**

DESCRIPTION OF ACTION:

Amending the Zoning Map Contained in Section 230-7 and Attachment 3 to Chapter 230 of the Village Code to Alter the Boundaries of the RU Zoning District to Include Eight (8) Parcels Currently Located in the RLD Zoning District (the "Project").

REASONS SUPPORTING THIS DETERMINATION:

The Village Board has reviewed the Full Environmental Assessment Form (FEAF) and the criteria contained in 6 NYCRR §617.7 and has determined that the Action will not have a significant impact on the environment for the following reasons:

- A. As required by §617.7(a)(2), the Village Board has determined that an Environmental Impact Statement is not required because any identified adverse impacts on the environment will not be significant.
- B. As required by §617.7(b), the Village Board has:
 - 1. Considered the action as defined in subdivisions 617.2(b) and 617.3(g).
 - 2. Reviewed the FEAF, the criteria identified in 617.7(c) and other supporting information to identify relevant areas of environmental concern.
 - 3. Analyzed the identified relevant areas of environmental concern to determine whether the action will have a significant adverse impact.
 - 4. Set forth herein is its written Finding of No Significant Environmental Impact.

- C. The Village Board has compared the impacts reasonably expected to result from the proposed action to the criteria listed in 617.7(c)(1) as indicators of significant adverse impacts:
1. Air quality, ground or surface water quality or quantity, traffic or noise levels, solid waste production, erosion potential, flooding, leaching or drainage problems;
 2. Removal or destruction of large quantities of vegetation or fauna, interference with migration fish or wildlife, impacts to special habitats, impacts to threatened or endangered species, or any other impacts to natural resources;
 3. Impairment of Critical Environmental Areas;
 4. Conflicts with currently adopted community plans and goals;
 5. Impairment of important historical, archeological, or aesthetic resources or community character;
 6. Major change in use or type of energy;
 7. Creation of a human health hazard;
 8. Substantial change in use or intensity of use of land including agricultural land, open space or recreational resources;
 9. Encouraging a population increase;
 10. Creation of a material demand for other actions resulting in above consequences;
 11. Changes in two or more elements of the environment that combined have a substantial adverse impact on the environment;
 12. Two or more related actions undertaken, funded or approved by an agency that combined have a significant effect on the environment.
- D. 617.7(c)(2) – For the purpose of determining significant adverse impacts on the environment of those factors listed above, the long-term, short-term, direct, indirect and cumulative impacts, including simultaneous or subsequent actions, to the extent reasonable, as included in any long-range plan for the action, any action that is a result of the reviewed action or is dependent on the action were reviewed.
- E. 617.7(c)(3) – The significance of any likely consequences was assessed in connection with the setting of the action, the likelihood of occurrence, duration, irreversibility, geographic scope, magnitude and the number of people affected as a consequence of the action.

Based on this review, the Village of Millbrook Village Board has determined that no significant adverse environmental impacts would result from this Action.

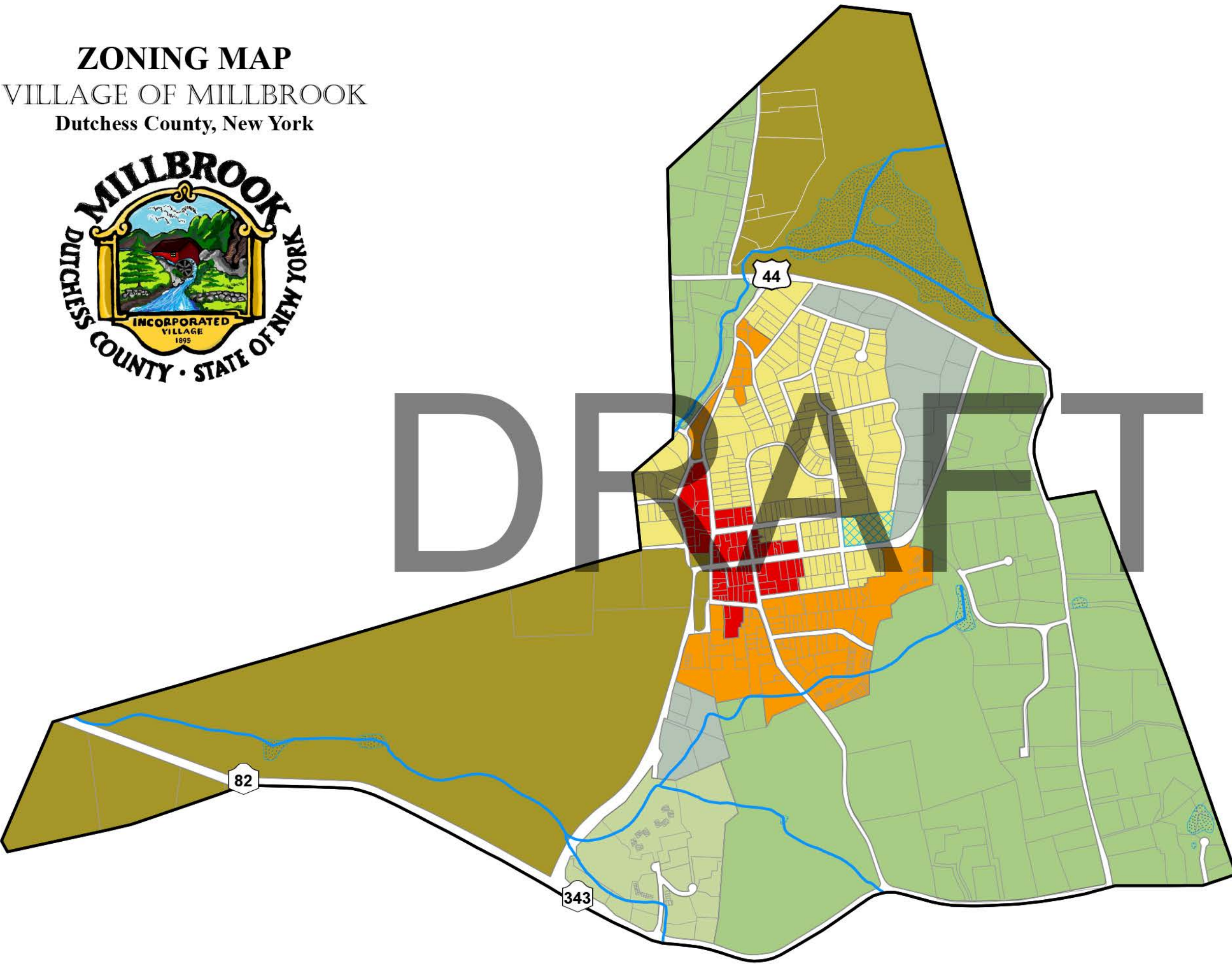

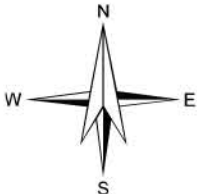
