**Motion made by Sorensen/Zacharias** to approve the Village of Oxford 2026 Sewer Fund Budget. Motion carried with a roll call vote and all voting "Aye".

**Motion made by Wastart/Holtz** to approve the road closures for the December 6, 2025, Christmas Parade routes. Motion carried.

**Motion made by Wastart/L. Drinkwater** to adjourn at 6:58 PM. Motion carried.
