NOW, THEREFORE, be it resolved by the Village Council of South Amherst, Lorain
County, Ohio, that:

Section 1: It is necessary to levy a tax in excess of the ten mill limitation for the benefit of
the Village of South Amherst, for the purpose of the South Amherst Fire
Department to provide and maintain fire equipment, apparatus and vehicles for tax
years **2024, 2025, 2026, 2027, and 2028 and which levy is a Renewal tax for a
five (5) year period.**

Section 2: The question of levying additional taxes to be submitted to the electors of the
Village of South Amherst at the general election to be held at the usual voting
place(s) within the Village of South Amherst on the 7th day November 2023.

Section 3: Said levy to be extended on the tax list of the Village of South Amherst, Lorain
County, Ohio of a majority of the electors voting thereon vote in favor thereof.

Section 4: The proposed tax is a renewal of an existing tax.
