

MINUTES FOR THE OCTOBER 14, 2025 TISKILWA VILLAGE BOARD MEETING

The Village of Tiskilwa Board held its regularly scheduled meeting on October 14, 2025 at the Tiskilwa Fire Station at 7:00 P.M. Answering roll call were Mayor Daniel Acker, Trustees Amy Kline, Brett Klinefelter and John Funderberg. Absent were Trustees Kayla Kunkel, James Cole and Daniel Yepsen. The Agenda was approved as presented. Trustee Funderberg made a motion to approve the minutes from the Special Meeting on September 2, 2025, seconded by Trustee Klinefelter. All ayes.

Payment of Bills: Trustee Klinefelter made a motion to approve payment of bills totalling \$114,377.44, seconded by Trustee Funderberg. All ayes on a roll call vote.

Treasurer's Report: Trustee Funderberg made a motion to approve the treasurer's report, seconded by Trustee Klinefelter. All ayes of a roll call vote.

Public Comment: There were four citizens at the meeting. One to discuss changing the ordinance of the creek.

Rick Funderberg Report: No issues at the water plant, waste water plant and parks.. Still waiting on bid for the installation of water fountains at Numosh Park. Lift Station #1 had a power surge and blew some components in the control panel. It was repaired by TEST. 124 new meters have been installed.

Mayor Acker asked for 2 things to be completed in the next month, a covert cleaned out by Arch Street and some trash cleaned up by a tree on the village right of way.

Reports:

Water Report: Trustee Klinefelter gave the water report as 800,300 gallons of water used, \$10,564.49 amount of water billed and \$7,413.65 amount of sewer billed.

Police Report: The Police Report showed 1 traffic stop, 30 security checks, 0 911 calls and 37.5 hours worked.

Engineer Report:

Jack Kusek, Village Engineer, stated by the end of the month the materials needed for the water filtration work should be in for that work to be completed.

Water Tower: The foundation for the water tower has been delayed till next spring.

The painting that was chosen we were told is \$7,000 more and will be discussed further at the next meeting.

Mayor Acker acknowledged Brandon Mallory for filling in at the Village Office while the Clerk was off. It was very much appreciated.

OLD BUSINESS:

The spray patch street work has been completed.

Weather Radio Survey: This survey will be in the water bills and new magnet calendar mailing.
